Sealed quotations are invited from interested parties (owners/estate agents/property dealers) for acquiring Space for Strong Room / Record Room on Rental Basis in Karachi.

- 1. The locations will be evaluated on the HBFC eligibility scoring criteria.
- 2. Proposed location must be located on Ground Floor.
- 3. HBFC reserves the right to reject any or all proposals as per PPRA Rules.
- 4. Title documents are required with the proposal.
- 5. Annual increment will be admissible maximum upto 10% of monthly rent (Negotiable).
- 6. In case the participating bidder is an Estate Agent, the commission is admissible equivalent to one (01) month rent payable only after contract signing between both parties.
- 7. Estate Agent must be registered with FBR.
